That the GHNNC also transmit this proposal to the City of Los Angeles requesting that they also adopt this for all residential projects. **Motion:** That the GHNNC Board allocate \$800 (\$400 per person) for two members to attend the 23rd Annual Land Use Law and Planning Conference, Friday, January 23, 2009, a UCLA extension Public Policy Program at the Millennium Biltmore Hotel in Los Angeles.
