Motion: That the GHNNC Board submit a letter to the City Council indicating our support of the ordinance with the following comments:"Prohibit locating such sites within 1500 ft of another, Maintain current zoning codes that regulate Community Care Facilities serving seven or greater residents, Prohibit Boarding/Rooming Houses of seven or more people in areas zoned one or single family. Require a Conditional Use Permit to locate in all other zones (including R3 and less restrictive zones), Prohibit subleasing under the Parolee/Probationer Home definition, Maintain Parolee/Probationer Home definition, and permit them as conditional uses in R-3 and less restrictive zones. This element must not be left intact as part of this ordinance, Add an Administrative Code Enforcement penalty provision to strengthen nuisance abatement regulations. Non-compliant Boarding/Rooming/Parolee houses that exist prior to the effective date of the enactment of this ordinance are required to comply within 6 months of the effective date."
