- GHNNC opposes 6 lots or 5 lots total, but would accept a total of 4 lots as discussed with the developer in early 2013

- To be consistent, these improvements should include: a horse trail along Mayerling; curb and gutter, half street to a consistent 64'; re-paving of Lerdo and widening where possible; street lights consistent with]adjacent areas of Mayerling;
