 - Therefore, the DWP Advocacy Committee recommends: That the rate increases not be approved until the Ratepayers have ample opportunity to review and analyze the charter mandated Industrial, Economic, and Administrative Survey;

That the rate increases not be approved until the Ratepayers have ample opportunity to review and analyze the report of the Ratepayers Advocate and its independent consultant;

That the Ratepayers Advocate prepare an ongoing list of questions concerning the Department, its finances, and is its operations;

That these questions be prepared with input from Neighborhood Councils and Ratepayers; That the Ratepayers Advocate, with the assistance of DWP, provides timely answers to these questions;

That the Ratepayers have ample time to review and analyze the answers to these questions;

That the Ratepayers have ample time to provide input to the City Council;

That the City Council discuss in an open and transparent manner the governance of DWP, including the recommendation of the LA 2020 Commission;
