- New chief of police: Jim McDonald
 - Significant amount of experience
 - Goals include: enhance public safety, trust, and relationships
- New general manager of the housing department: Tana ??-Hall
 - Produce, preserve, protect affordable housing
- Sid questioned the Mayor's feelings on council's lack of involvement with ICE
 - "Any city employee will not work with any agency regarding immigration (most likely)"
- Catherine asked about the recruitment plan and vacancy in the LAPD
 - He offered to give her a business card for further questions
 - Full staffing is back to 10,000; currently 8,738
 - Discussed the rash of burglaries in the area
- Brian mentioned that policemen are precluded from duties due to the city council/mayor's office's new implementation on LAPD regulations
- "Something needs to change (hostages, burglaries in broad daylight, etc.)"
- There is strong concern for what this city is doing (Sanctuary City Issue) and it in theory is a crime
- Gary also questioned David about the police and what they are/are not able to do regarding homeless break ins and police response
- Maria brought up that the safety committee should have a position taken by the GHNNC
- PEOPLE SHOULD ACTUALLY GO TO LAPD MEETINGS
- No updates about the cert program
- "Anything an individual stakeholder says is their individual viewpoint, not the viewpoint of the entirety of the chamber and we shouldn't take a collective viewpoint unless it is an agenda item." Brian + Graham

- Motion was overturned by Brian because he agreed with the idea and said a motion was not necessary

- Balboa brush clearance was completed
 - However, no follow up unless there are complaints
 - Suggested taking videos of Balboa to compile evidence to there would be accountability if not fully completed
 - From Rinaldi to the 5 Freeway
 - Between Rinaldi + Westbury the wall has been cleared and the sidewalk is free
 - Playground repairs (sandbox + swings are repaired/up to working conditions)
 - Graham says to check out the list that was put together regarding

- Trying to get Wayne + Paola to hear out maintenance issues so we can collaborate on a solution
- We need community support (power in numbers to get Councilman Lee's office to sign off on the needed maintenance)!
- Issue with moles + gophers building giant holes in fields
 - They are an invasive species with really no predators
 - Not ready to make an actionable item at this point
- Coordinate with outreach to get testimonials from people affected
- Alexandra (me) can talk to Councilmember Lee on Thursday to bring up some maintenance issues, NOT WITH THE BOARD BUT WITH THE COMMITTEE
