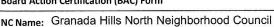


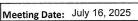

Deer Councilmember Lee,

Granada Hills North Neighborhood Council is writing to you today with a potential resolution to the issue of the vacant lots at the corner of Rinaldi and Balboa. As you know the property once was a gas station. No proposed developments have been approved for that site since the gas station closed. The reason for the property being vacant for more than 20 years is that of public safety. A few years ago, a survey was conducted of the residents (in the area of property) and the overwhelming response of more than a hundred respondents was that they did not want to see more congestion and accidents at that corner by inviting more auto traffic to that corner.

I am sure you know that that corner has been and still is a very dangerous intersection. There are frequent accidents, sometimes daily, but there is rarely a week that goes by when there is not an accident. With that in mind the consensus is and has been that there is no development that would not cause a threat to public safety should it include additional auto traffic.

Therefore, it is the view and desire of the council to take action to support the community by recommending the City purchase the property and develop it into a local pocket park for residents to use as a walking and relaxing area which could also have facilities for exercising as well.

There is no other rest areas in the local area for residents to walk to. Such area would also be beneficial to residents for walking their dogs. Additionally, with three mini markets, one on each of the other corners such a park would provide an option for those employees to take a break and relax or eat lunch without having to drive to another facility.

Our opinion is that the price would be worth incurring if we were to support our stakeholders and provide a safer area for residents and workers to enjoy, that is close by. The closest pocket park to this location is Rinaldi and Reseda, and that is considerably smaller and in Porter Ranch. It does not have the traffic or business close by either.

Finally, when the council was engaged in discussions with the property owner a few years ago regarding their desire to develop a car wash the owner had offered to entertain an offer to purchase the land when he realized there was no support for his desired development.

Granada Hills North Neighborhood Council

Of all the options to date there does not seem to be a better use for the property than a pocket park. That said, if nothing is approved for this property it will continue to be an eye sore costing the owner to periodically clean the weeds and growth while residents receive no benefit but having to look at a lot full of ads and wild growth of grass and weeds.

If we can use the Sunshine Canyon Amenities Fund to rebuild the Petit Park pool to the tune of \$11,000,000, I would hope we could spend \$2,000,000 to \$3,000,000 to provide support for the residents of Granada Hills North to enjoy an area close by their homes.

We look forward to further positive discussion on this recommendation in the near future. Please let us know what additional information you may need to address or make a positive decision.
