Candidates and those in office would not be aware of the names or institutions that had donated money to them.

- No money will be given directly to third-party support groups that identify themselves with supporting a campaign or proposition. Money will be placed in a blind trust and the campaign as well as the candidate will not be aware of who donated the money. As him
- All labor negotiations conducted with the government and their unions will be done by managers in and non political advisors to that department. No elected official shall participate in labor negotiations with government unions
- An elected official will be recused from participating in making a decision regarding a contract to any relative through blood or marriage, this would include spouse, dependent children, independent children, dependent children spouse independent children spouse, siblings, siblings in law, uncle blood or in law, aunt blood or in law, cousins blood or in law first, once removed and second and or close friend, previous business associate partner or ant person where a possible conflict of interest may exist..
- Behested payments in the name of candidates or officials would be considered unethical and not be allowed.
- Elected officials, their immediate families would not be allowed to be active participants (boards or committees of that charitable organization) in charitable foundations that receive government funding in any form.

 - c. AB 1851 (Wicks) would prevent cities from denying the housing development built a church parking lot solely on the basis of that would reduce parking spaces:
 - d. SB1120 (Toni Atkins) allow duplexes to be built by right and single-family zone and would also allow unlocked for single-family zone to be divided into two parcels:
 - e. AB3040 occurs cities to rezone single-family parcels to allow duplexes, complexes and for flexes and to be counted as to visit potential developments:
 - f. SB902 (Scott Wiener) would allow cities to rezone land to be built up to 10 homes per parcel if the parcel is located in transit rich area, or on and urban infill area without having to go through the California environmental quality act process:
 - g. AB3107 (Bloom, Ting) require cities to allow housing developments and commercially zoned areas is at least 20 parcels of the unit and project were affordable to lower income:
 - h. SB 1385 (Caballero) allow housing development on neighborhood lots defined as parcels within an office or retail commercial zone a minimum of 20 units per acre and other restrictions apply:
 - i. SB 1299 would create grants for cities that rezone idle sites for formerly used for big-box retailer or commercial shopping center and instead allow the development of workforce housing.
