I'm injured and lost in the forest. I can't get a cell signal. Can you find me?

A wildland search and rescue plan includes lost hiker and distressed hiker searches, hiking assessment exercises, land navigation, and full functional drills.

Tom Wirth has been a Battalion CERT Coordinator with the City of Los Angeles for the last 18 years and is the Planning Section Officer for the LAFD ACS (Auxiliary Communications Service). Over the last six years Tom has developed a wildland search and rescue plan for the city's ten largest parks. He'll discuss how this plan adds a new dimension to CERT training and gives non-CERT trained residents an opportunity to come out to our parks and train in wildland search and rescue techniques.
