The concern is that the sedimentation includes particulate matter in the 2.5 micron and 10 micron range, harmful to humans; that the sediment contains heavy metals from erosion of soils; that this sedimentation could be harmless if buried, but would be harmful if exposed to dryness and winds which will carry this dust throughout the neighborhood.
