Leon Marzillier, Chairperson of GHNNC, opened the meeting at 6:40 with a roll call of board members present: Mary Ellen Crosby, Sue DeVandry, Sid Gold, Bill Hopkins, Wayde Hunter, Gary Holman, Skip Leifer, Agnes Lewis, Leon Marzillier, Ray Pollok, Eric Rosenberg, Joe Vitti and Anne Ziliak. Quorum established with 13 board members. Late arrivals: Josh Jordahl, Mike Greenwald & Scott Manatt.
14 15 16 17 18	2.	Policy & Rules Committee Chair Eric Rosenberg called the meeting to order at 6:45 p.m. He led the assembly in the Pledge of Allegiance. He then explained the process of voter certification, rules and meeting procedures and presented an overview of the proposed bylaws changes.
19 20 21 22	3.	Committee members then made comments, especially commending Eric's outstanding efforts to bring this document to the point where we could all discuss it. There were no questions asked by stakeholders.
23 24 25	4.	First Proposed Motion: "That we amend and restate GHNNC Bylaws Article 2 (Definitions) as proposed by the Policy & Rules Committee. The motion carried by unanimous consent.
26 27 28	5.	Second Proposed Motion: "That we amend and restate GHNNC Bylaws Article 3 (Boundaries) as proposed by the Policy & Rules Committee. The motion carried by unanimous consent.
29 30 31 32	6.	Third Proposed Motion: "That we amend and restate GHNNC Bylaws Article 5 (Stakeholders) as proposed by the Policy & Rules Committee. Stakeholder Stacy Rosenberg pointed out a typo requiring a clerical change. The motion carried as amended by unanimous consent.
33 34 35 36 37 38	7.	Fourth Proposed Motion: "That we amend and restate GHNNC Bylaws Article 6 (Composition of the Board) as proposed by the Policy & Rules Committee. (Hopkins/Leifer) proposed an amendment to 6.3 b. "Environmental Representative" that, "This director is a stakeholder who is an actively involved member of an environmental organization that meets regularly at least four times annually within the neighborhood. (Hunter) offered a friendly amendment adding the words, "and deals with environmental issues that also affect the neighborhood."

8. Fifth Proposed Motion: "That we amend and restate GHNNC Bylaws Article 9 (Officers of the Board and Their Duties) as proposed by the Policy & Rules Committee.

(Hopkins/Rosenberg) moved to amend the opening paragraph "Nominations and elections for these positions will take place utilizing standard election procedures including run-offs in the case of three or more candidates..." to "in the case of 'two' or more candidates." The motion to amend failed: 4-17-0.

(Hopkins/Rosenberg) moved to amend 9.3 The Secretary from "Will keep the minutes...and keep a file of all communications received or sent" to "keep a file of all communications received and/or sent." The amendment carried unanimously. The motion to approve Article 9 as amended carried unanimously.

- 9. Sixth Proposed Motion: "That we amend and restate GHNNC Bylaws Article (Neighborhood Council Elections) as proposed by the Policy & Rules Committee. (Hopkins/Thompson) moved to amend 7.6 Qualification for Directors from "To run for a seat on the GHNNC, a Stakeholder must be eighteen (18) years of age or older by the date of the election, except for the candidate for Student Representative, who must be sixteen (16) years of age by the date of the election" to "except for the candidate for Student Representative who must be between the ages of 16 & 25 by the date of the election." (Rosenberg) added a friendly amendment, "who must be sixteen (16) but not more than twenty-five (25) years of age by the date of the election." The amendment carried: 18-3-0. The motion carried as amended by unanimous consent.
- 10. Seventh Proposed Motion: "That we amend and restate GHNNC Bylaws Article 13 (Ethics) as proposed by the Policy & Rules Committee." (Hopkins/Thompson) moved that the second paragraph be amended adding the word "official" to read, "This information will be posted on the Council's "official" website." The amendment carried: 12-5-0. The motion as amended carried: 18-0-1.
- 11. Eighth Proposed Motion: "That we amend and restate GHNNC Bylaws Article 15 (Changes to These Bylaws) as proposed by the Policy & Rules Committee." (Hopkins/Thompson) moved to change the words "two weeks" to "14 days." The amendment carried: 10-6-0.

(Rosenberg/Rosenberg) moved to add the amendment, "These Bylaws shall only be amended by the "affirmative" vote of two-thirds (2/3) of Stakeholders present at a Special Meeting called for that purpose exclusive of abstentions and recusals." (Striking the phrase [meaning that two-thirds (2/3) of the Stakeholders' votes cast... must be in the affirmative."] The amendment carried unanimously. Article 15 carried as amended by unanimous consent.

- 12. Ninth Proposed Motion: "That we amend and restate GHNNC Bylaws Exhibit 1 (Stakeholder Verification Form) as proposed by the Policy & Rules Committee. (Hopkins/Rosenberg) moved to change the description following Student (ages 15-25) to "age 15-25). The amendment carried unanimously. The motion carried as amended by unanimous consent.
- 13. Tenth Proposed Motion: "That we amend and restate GHNNC Bylaws Article 4 (Council Objectives & Policies and Stakeholder Communication) as proposed by the Policy & Rules Committee. (Hopkins/Hunter) proposed an amendment to 4.1 "After the best-faith efforts to solicit opinions from Stakeholders, the Council shall advocate to the City those public policies that are most likely to enhance our quality of life," to "that are likely to enhance our quality of life." The amendment failed: 7-12-0. Article 4 was approved intact by unanimous consent.

During 187 discussion, Hunter withdrew his second and the motion was withdrawn. 188 189 190 14. 7. f. The motion failed: 5-11-1. 192 193 The stakeholders present requested that the Policy and Rules Committee consider whether or not 194 to specify committee chairmanships. The motion carried: 16-0-2.
