1. Call to Order, Roll Call, Pledge of Allegiance, Welcome/Introductions/Calendar

- 2. Comments from CD 12, LAPD Senior Lead Officers, Elected Official Reps, Government Agencies LAPD Officer Angeles gave crime statistics for the Granada Hills area. C. Public Safety – Ray Pollok, and Emergency Preparedness Sub-Committee Reports – Bill Hopkins

Ray Pollok spoke about the topic of their last meeting which was the issues created by the new DMV facility on San Fernando Mission Road. He said the issue has been forwarded to the PLUM Committee.

D. Outreach Committee Report – Jim Summers

a. <u>Candidate Forums:</u> Possible motion (not from the Committee) to approve \$100.00 from Outreach, to support a Candidate Forum for LAUSD School Board District 3 (6 candidates) and Board of Trustees for the Los Angeles Community College District 3 (4 candidates). b. GH Annual Spring Egg Hunt Possible motion (not from the Committee) to approve \$500 from Outreach, to help with the purchases of supplies. Co-sponsored with L.A. Dept. of Parks & Recs and GHSNC, on Sat. March 28, 2015 at Granada Hills Rec Center. This event is free to the community and includes Arts & Crafts, Face Painting, Carnival games, a moon bounce, music, prizes and an Egg Hunt to conclude the event.

The motion was made by the Outreach Committee but there was no second, therefore no vote.

E. Citywide Committee Report – Sid Gold

a. Resolved that GHNNC correspond with the Department o Water and Power, and mayor Eric Garcetti that in accordance with the MOU between DWP and Neighborhood Councils, that no action be taken on any change in the rate structure be taken until all NC signatories of the MOU be given notice of any proposed change. Resolution was approved by the Board by a show of hands.

- b. Resolved that GHNNC opposes the implementation of the Army Corps of Engineers, alternative 20, LA river Ecosystem Restoration project as written and Further resolved GHNNC recommends that Los Angeles City Council not take any further action until the details and unexamined issues have been addressed and Further resolved that GHNNC write letters concerning our opposition of the project as written to Senators Diane Feinstein and Barbara Boxer, members of the Los Angeles Congressional Delegation, Further resolved notice of GHNNC's action be submitted to City Clerk as a CIS and to Mayor Eric Garcetti and Councilman Mitch Englander
 - Resolution was approved by the Board by a show of hands.
- Resolved that GHNNC write a letter to Councilman Herb Wesson, president of the Los Angeles City Council requesting that Neighborhood Councils be recognized as City entities and be given equivalent opportunities as other city Entities to make oral presentations to LA City Committees, Commissions and Council.
 - Resolution was approved by the Board by a show of hands.
- d. Resolved that GHNNC write a letter to Mayor Eric Garcetti that he engage with the Veterans Administration regarding Bentwood VA regarding the making the availability of the Brentwood facility for housing for the more than estimated 50,000 homeless veterans within Los Angeles. Resolution was approved by the Board by a show of hands.

F. Parks and Beautification Report - Bill Cotter

a. Update on Sesnon clean up.

Bill Cotter reported that approximately 50 stakeholders participated in the clean-up in January. He thanked the Board members who attended along with LAPD and a staff member from Mitch Englander's office. Bill is planning monthly cleanups, the last Saturday of each month, based on input from the Board and stakeholders.

G. PLUM Report – Jan Subar/Agnes Lewis

a. Motion that the GHNNC Board write a letter to be sent to: Scott Wilk, CA State Assembly; office of Governor Jerry Brown; the head of the CA DMV; with a copy to LAPD Mission Division and Councilmember Mitch Englander; requesting that the DMV Supercenter office at San Fernando Mission and Woodley be made into an appointments-only office, to mitigate the traffic and parking impacts on the immediate neighborhood caused by the massive volumes of driver's license applicants.

The motion to add Devonshire Division in place of Mission Division was passed with a vote of 16-0-0

The amended motion was passed with a vote of 16-0-0.

b. Motion that a letter be sent to the LA County Board of Supervisors and LA County Department of Public Works opposing the parts of the County sedimentation plan that allows the removed sedimentation to be used as daily cover for the landfill operations at Sunshine Canyon Landfill. The concern is that the sedimentation includes particulate matter in the 2.5 micron to 10 micron range, harmful to humans; that the sediment contains heavy metals from erosion of soils; that this sedimentation could be harmless if buried, but would be harmful if exposed to dryness and winds which will carry this dust throughout the neighborhood. After much discussion, the Board agreed to substitute the following motion in lieu of the one

originally presented.

The motion to amend the original motion was made by Sid Gold and seconded by Ralph Kroy. The amended motion reads,

Motion that a letter be sent to the LA County Board of Supervisors and LA County Department of Public Works stating that the GHNNC recommends that no action be taken on moving sediment from the Devil's Gate Reservoir Sediment Removal and Management Project to the Sunshine Canvon Landfill until a local EIR is completed.

Vote- Yes-13, No-0, Abstentions-3 (Sherman, Watson, and Zero)
