There is now a dedicated website for the issue, which may not be resolved for several months. A couple hundred people have been relocated from the affected area with many more on the waiting list. In respect to the project to widen Balboa Blvd/ at Rinaldi (SW corner)- the city does not have the funds to purchase the property near the gas station which also included the removal of a gas pump, which the city has to pay for.
