- Call to Order, Roll Call, Pledge of Allegiance, Welcome/Introductions/Calendar
 Meeting was called to order at 6:30pm by President Michael Greenwald.
 Members present included Samuel Andress, Sid Gold, Michael Greenwald, Bill Hopkins, Ralph Kroy, Betty Moreno, Amanda
 Nall, Ray Pollok, Rob Sherman, Vanessa Silver, Jan Subar, Jim Summers, Joe Vitti, Victoria Watson, and Donna Zero.
 Absent members included Mike Chibidakis, Bill Lillenberg, and Rahim Kazi
 Also in attendance were 22 stakeholders.
- 2. Comments from CD 12, LAPD Senior Lead Officers, Elected Official Reps, Government Agencies Millie Jones (Field Deputy, CD12) announced that Megan Cottier has taken another position. Millie will be in her place until a replacement is found. She spoke about the impact that the gas leak in Porter Ranch has had in the area. Councilman Englander has been in close touch with all agencies concerning this issue. She said there are multiple jurisdictions involved in this matter. She left information with phone numbers for AQMD and the Gas Company. Also mentioned was the Nurse Practitioner program that will be part of the Fire Dept. services to help with non-emergency medical situations. Next meeting on the O'Melveny Park issue concerning runners will be on January 29 at 6pm

Ray Pollok on behalf of our SLO Janine, who advised that everyone keep their car locked.

Jacqueline Serrano, Congressman Tony Cardenas office, brought information and offered the services of their office. Also said that federal and state income taxes can be filed beginning on Jan 19 and must be filed by April 18, 2016.

Bill Ulmer Assembly District 39, gave an update on pending legislative actions.

- 3. Public Comment on non-agenda items (limited to two minutes)
 - G. Paleno (AYSO) spoke on behalf of the issue of installing lighting on the soccer field, located on Balboa Blvd., so that players can play at night. He voiced concerns about when the lights will be turned out and if the light will be used in the summer to extend play.

Glenn Bailey, Budget Advocate, passed out cards to encourage participation in the City Budget Process which was extended until Jan 15, 2106. He also said that at the last advocate meeting, the Aliso Cyn. Gas Leak was discussed in terms of the financial impact of this incident. He also said the definition of "Community interest stakeholder" is being looked at and may affect the April elections.

 Rob Sherman moves, Jan Subar seconds. Motion passes Yes-14, No -0, Abstention -1 (Watson).
- Emergency Preparedness Item of the Month Bill Hopkins presented this month's item which was a pair of utility gloves.

 - **a.** Motion to move funds within the GHNNC Budget.
 - a. Move \$13,000.00 from 200 Outreach to 100 Operations. Move funds from Line 14 (Meeting Space Rental) \$1,200.00, line 17 (Newsletters) \$8,000.00 and line 22 (Misc. Outreach) \$3,800.00 to Line 4 (Facility Rent) \$10,836.00, Line 6 (Phone and Internet Systems) \$1,551.01 and Line 10 (Website Expenses) \$612.99. If any of these expenses are reduced or additional funding comes in from the City the monies will be moved back to the original budget lines.

Agnes Lewis, co – chair spoke on behalf of the committee. The letter pertaining to the motion below has been sent to residents on Woodley, overlooking the soccer fields. She said that the properties are at least 600' from the border of the fields. She said there were no objections to the letter. She and Mike Greenwald walked the neighborhood and spoke with residents.

Oscar Jimenez, AYSO Commissioner, said that even with light, games should end by 8pm. Ralph Kroy requested the use times need to be submitted in writing, along with contact information.

Christine Mayberry, a new resident, said that in her previous location there was lighting. Limit the issues to times, permanent or portable, and who has access to the lights.

Note: the lease on the property is from sunrise to sunset. The lease needs to be changed pending the approval of this request.

Wayde Hunter suggested that we get the agreement in writing before voting.

a. MOTION: That GHNNC approve the request from AYSO Region 174 for support of their project to install lighting on the youth sports fields at 13100 North Balboa Blvd, provided that a letter be sent to the dozen or so properties abutting the area to the southeast, to inform them of the project and give them an opportunity to comment.
