- 1. Call to Order, Roll Call, Pledge of Allegiance, Welcome/Introductions/Calendar Meeting was called to order at 6:30 pm. - 2. Comments from CD 12, LAPD Senior Lead Officers, Elected Official Reps, Government Agencies Barry Stone, Empower LA, is our new contact (replaced Melvin Cañas) and requested a copy of our roster so we can receive timely communications. It is now the time to update our By-Laws. The Mayor's office asked that each NC appoint a Homeless Liaison.

- **6.** Motions, possible motions and discussion items for Board Meeting:
  - **A.** Executive Committee
    - Motion to remove Ruby Madison from the Board as called for in the Standing Rules II 11 for missing three (3) consecutive regular meetings.
       Motion approved. Yes- 13, No- 0
    - II. Motion to add verbiage on the use of the office to the standing rules.
      An open discussion on the new wordage took place.
      Sid Gold arrived at 7:09 pm
      Barry Stone suggested that we contact the city attorney about the wordage for this item.
    - III. Schedule By-Laws Committee meeting.
      Barry Stone suggested that we contact the city attorney about the wordage for this item.
    - IV. The Granada Hills North Neighborhood Council is coordinating a street banner campaign. The purpose of the street banners is to promote the Granada Hills North Neighborhood Council. We therefore move that the City Council, in accordance with the Los Angeles Municipal Code (LAMC) section 62.132, approve the Street Banner program identifying the Granada Hills North Neighborhood Council as a City of Los Angeles Non-Event Street Banner Program. FURTHER MOVE that the Council approve the content of the street banner design, as attached.

Mike Greenwald suggested that the banners contain information on those from Granada Hills who lost their lives in service of their country. Another suggestion was that we change the color to make them more noticeable.

     Motion approved. Yes- 13, No- 0, Ineligible -1 (Nall)
  - **II.** Follow up on outstanding items. *At this time there are no outstanding items.*
- C. Planning and Land Use, Report
  - I. Motion: Regarding CPC-2016-837-SP-MCUP and CPC-2016-838-DA, a proposed regional shopping mall on Rinaldi west of the current one.
    - \* That GHNNC write a letter to the City Planning hearing officer, May Sirinopwongsagon, supporting the Porter Ranch Neighborhood Council's generally favorable recommendations;
    - \* recommend that the City require the Developer to make good on the agreement to dedicate a 2-acre site to the City for future development of services, even if the City today does not have the funds to build on this site (a projected library, community center, and a child-care facility). There is no reason to relieve the developer of this agreed-upon responsibility. The City should realize that many years hence it will be immensely harder to re-acquire land for such uses, and the land can meanwhile stay undeveloped:
    - \* accept the Developer's offer to have a 4,000 sq. ft. community room available on the second floor of the shopping center, as long as it will be publicly available including evenings and weekends:
    - \* recommend that the City look into additional traffic mitigation, including additional on and off ramps to the 118 Fwy and widening of the streets adjacent to the project.

      Friendly amendment to remove wording from the original motion failed. Yes- 4, No -7, Abstain-3

      Original Motion approved. Yes-14 No-0
  - **II.** Motion that GHNNC write a letter to Devonshire Division and CD12, asking for increased enforcement of RV parking rules, and post the necessary signs in the proposed enforcement areas.

Suggestion was made to request signs for no overnight parking. There are no specific guidelines for parking RVs.
